AMENDMENT TO RESIDENTIAL HOUSING RESTRICTION AND NOTICE OF LIEN FOR "BLUE 52 TOWNHOMES"

HOUSING AUTHORITY OF BRECKENRIDGE, SUMMIT COUNTY, COLORADO

This Amendment to the Residential Housing Restriction and Notice of Lien For "Blue 52 Townhomes, Town of Breckenridge, Summit County, Colorado (this "Amendment") is made by the Town of Breckenridge Housing Authority (hereinafter referred to as the "Housing Authority") this // day of // day of // 2019.

WHEREAS, Housing Authority caused the "Residential Housing Restriction and Notice of Lien for Blue 52 Townhomes, Town of Breckenridge, Summit County, Colorado" to be recorded on December 13, 2017 at Reception No. 1159018 of the records of the Clerk and Recorder of Summit County, Colorado (the "Restriction"); and

WHEREAS, the Restriction provides that Exhibit C, Exhibit D, Exhibit E, and Exhibit F to the Restriction will be amended after all of the units in the Project have been sold; and

WHEREAS, all of the Units in the Project have now been sold, and the Housing Authority desires to amend Exhibit C. Exhibit D. Exhibit E, and Exhibit F as hereafter provided.

NOW, THEREFORE, Housing Authority hereby amends the Restriction as follows:

- 1. **Exhibit C** to the Restriction, previously entitled "List of 110% AMI Units," is deleted and replaced in its entirety by the attached **Amended Exhibit C** that identifies the Units in the Project that are designated as 110% AMI Units.
- 2. <u>Exhibit D</u> to the Restriction, previously entitled "List of 120% AMI Units," is deleted and replaced in its entirety by the attached <u>Amended Exhibit D</u> that identifies the Units in the Project that are designated as 120% AMI Units.
- 3. <u>Exhibit E</u> to the Restriction, previously entitled "List of 140% AMI Units," is deleted and replaced in its entirety by the attached <u>Amended Exhibit E</u> that identifies the Units in the Project that are designated as 140% AMI Units.
- 4. **Exhibit E** to the Restriction, previously entitled "List of Units Without An AMI Cap," is deleted and replaced in its entirety by the attached **Amended Exhibit F** that identifies the Units in the Project that are designated as Units without an AMI Cap.
- 5. All exhibits referenced in this Amendment are incorporated into this Amendment by reference.
- 6. All capitalized terms used in this Amendment that are defined in the Restriction have the same meaning as provided in the Restriction.
- 7. Except as specifically amended by this Amendment, the Restriction continues in full force and effect.
